However, we believe our new name will more ably represent our expanded future role as a care provider that integrates physical and behavioral health care across the age continuum, and best represents our expanded geographical footprint.

I am so very proud to be leading the combined organization as Darrell retires after 29 years with Uplift. He leaves the agency with a strong foundation upon which to expand our reach into more communities in need, and we are so grateful for his heart, intellect, and enthusiasm for this work.

On behalf of the Executive Leadership Team and our Board of Directors, we are excited by the opportunities that lie ahead as we begin to experience the extraordinary benefits of a combined organization. We believe that we will be better together-and so will the communities and customers we serve

Strengthening Children and Families

OUTPATIENT MENTAL HEALTH SERVICES are clinic and community-based treatment services, offered at home and school, for children, teens, and adults with a range of behavioral health problems. These services help families alleviate suffering, recover from trauma, restore and maintain a healthy level of day-to-day functioning, and work toward optimal growth and development at home and in the community. These services are funded primarily through county behavioral health departments. In some cases, they are funded by health plans or schools.

Of the 4,481 children, teens, older youth, and adults served in our community or clinic-based outpatient programs:



Stayed out of trouble with the juvenile justice system



Avoided suspension and/or expulsion



Maintained at home or in a family setting

Easing Transitions and Overcoming Obstacles

INTENSIVE BEHAVIORAL HEALTH SERVICES occur frequently and are often combined with social services to address social determinants of health (ie: access to safe housing, food, and health care). They usually include 24-hour on-call crisis response. The primary focus of these programs is to prevent children, teens, and older youth from being placed in a more restrictive level of care, or to transition them from these higher levels of care back into the community. These services are primarily funded by county behavioral health and social service departments. They may be also funded by the local Regional Center.

Working With Families to Improve Well-being

CARE COORDINATION SERVICES involve organizing care and information among team members to achieve more effective care, ideal for those with simultaneous social services, behavioral health, and physical health challenges. This includes Child and Family Team Facilitation (CFT) and our Health Home Program. Services are funded by county social services and health plans.

Danielle's story

Danielle, 39, was referred to Uplift Family Services after a long history of verbal, emotional, and physical abuse. She had finally worked up the courage to leave her partner of 20 years when police and CPS involvement made her fear losing

her children. Unfortunately, two decades of doing exactly what her ex told her with threats of deportation left her feeling worthless, unsure of her ability to assert herself and make good decisions, and thinking she would be better off dead. But with our team's care, time, and support, she was able to overcome her fears and anxiety, start to set safe boundaries, and feel more confident in her ability to make good choices. She reported that having someone to discuss decisions with helped her learn to make them for herself, and she feels

better about her future.



Stabilizing Children

CONTINUUM OF CRISIS CARE

SERVICES include behavioral health services for children, teens. and adults who may be a danger to themselves or others. Our programs include Santa Clara County's Post-Crisis Stabilization Services, Mobile Response Stabilization Services, Crisis Stabilization Unit. and Placement Services and Crisis Stabilization

Response Team as well as Mobile Crisis Response Services in Solano County. These services are primarily funded by county behavioral health departments. Our Inland Empire team also provides Intensive Behavior Support Services for children, teens, and older youth with developmental disabilities, which are funded by the Regional Center.

Connecting With Children and Parents

COMMUNITY-BASED WELLNESS SERVICES are prevention and early intervention services for children, adults, and their families. In Los Angeles, we offer the Hollygrove Haven after-school program and the Parent Institute. In the Bay Area, we offer Addiction Prevention Services. These services are primarily funded through donations or public sources of funding.

There were 755 children, teens, and older youth served.

Helping Students Learn

EDUCATIONAL SUPPORT SERVICES are designed to help students succeed in an educational setting. They include classroom consultations, parent workshops, youth groups, and individual and family therapy. These services are primarily funded by county behavioral health departments and school districts.

Building Nurturing Families

FOSTER CARE AND ADOPTION SERVICES offer accredited Resource Family Approval, Professional Parenting, Intensive Services Foster Care, Therapeutic Foster Care, and Adoptions with the goal of helping children and teens find a forever home. These services are funded by county social service departments.

Integrating Physical and Mental Health

WHOLE PERSON CARE SERVICES integrate physical health, mental health, and substance use disorder services, as well as care coordination with other community resources. Services take into consideration all aspects of a person's health, as well as their socioeconomic status, housing situation, and more. These services have braided funding.

Noah's story

Seven-year-old Noah was referred to our School-Linked Services program with high levels of anxiety that made it difficult for him to socialize with anyone besides his mother. He would cry and refuse to leave his

mother's side for school, and would have angry outbursts whenever he was asked to transition off one of his main sources of comfort: video games. When the pandemic hit, he was no longer able to attend community programs, so he joined our video game therapy group. As the youngest participant, he benefited from watching the older children model positive social and communication skills, which helped him build strong relationships with other members of his family. He has also learned self-regulation, and his mother reports that she can now leave her son's side to go run errands without triggering his worries and fears.

Meeting Families Where They Are

DEVELOPMENTAL DISABILITIES SERVICES use Applied Behavior Analysis (ABA)which applies scientific interventions to address behavioral needs-to improve language, social, and life skills for children and teens with Autism and other developmental disabilities. These services are funded by Regional Centers and Managed Care.

Community Hero Awardees

We honored Frank Rimerman + Co., the largest contributor to our holiday giving program, with the Community Hero award at our most recent Hearts & Hands virtual event. Since 2009, their team has spent approximately \$150,000 out of their own pockets to purchase, wrap, label, and deliver more than 4,000 gifts to ensure no child in our care will go without during the holidays. We are privileged to have such a committed and dedicated corporate partner.

Wheel of Fortune

When long-time board member Scott Kolbrenner won the March 18, 2021 episode of "Wheel of Fortune," we were honored that he generously chose to donate his winnings to Uplift Family Services and the Los Angeles Regional Food Bank. His \$145,000 victory makes him the fifth biggest winner in the show's 46-year history.

Los Gatos Orphanage Entrance Revamp

In March 2021, alumnae of the historic Ming Quong Home, a legacy organization of what is now Uplift Family Services, spearheaded a campaign to restore the 85-yearold arch that marked the entrance to the Los Gatos orphanage in the 1930s. In eight weeks, they raised more than \$25,000, and the finished product will be a point of pride for generations to come.

Trinity Lutheran Church Grant

When Trinity Lutheran Church in Walnut Creek realized they would have to close their doors, their community came together to figure out how to establish a <u>lasting legacy</u>. As a result, the church recognized Uplift Family Services as one of 34 organizations that "support the physical and spiritual needs of people in their community and beyond" with a \$156,000 grant to support our Los Angeles-based Hollygrove programs.

Despite the challenging adjustment, it soon felt as though they had always lived there. In early 2020, their adoption was finalized, officially expanding the family from seven to ten! Angela and Douglas are a busy pair, staying active in their church, coaching their children's various sports teams, and going on family camping trips. This year, the Capital Region presented them with the Adoption Family of the Year award at the Calling Out of Names Ceremony in honor of National Adoption Awareness Month.
