The ELEVATE Eligible Employers List is used to verify organizational eligibility for San Diego Pay It Forward loan forgiveness (including Incumbent Worker Benefit) and Upskilling employment retention incentives. To qualify, individuals must provide direct behavioral health services and support to the Medi-Cal eligible population.

At this time, exception requests are not being considered. Eligibility is limited to organizations that are County of San Diego Behavioral Health Services (BHS) contractors or subcontractors per the County’s guidance.
